## Letter of support- Callister Trust Garden Pavilion

We, Grow-Wellbeing CIC, are wholeheartedly in support of the development and building of a new pavilion in the Callister Trust Garden in Slatey Road, Oxton, Birkenhead.

Over the past four years, Grow-Wellbeing has used the garden as a venue for many activities and workshops to support the health and wellbeing of local residents. Some of those activities have been as a result of the Callister Trust commissioning of Grow-Wellbeing to facilitate activities. These include Women's Wellbeing workshops (for vulnerable women attending other third sector support groups, including the Spider Project, WEB and the Women's refuge); nature wellbeing sessions for young people with mental health issues from a local school; family nature workshops for refugee and asylum seekers awaiting their applications to stay in the UK. We have also facilitated workshops independently, and the Callister Trust have kindly agreed to allow us to offer our craft weaving workshops, and other nature workshops for families and young people in the beautiful garden environment, which has a variety of spaces that provide an uplifting of the spirit for the participants that we have supported.

The Pavilion would improve the provision at the garden, which currently only offers rudimentary washing and toilet facilities. It would provide refuge from adverse weather, where currently there is only one small outbuilding with a basic kitchen facility. As Grow-Wellbeing's activities are focused on nature connection, they are all scheduled outside but there have been occasions when significant adverse weather has meant that we have had to cancel sessions. The Pavilion would provide an alternative environment which would ensure all of our sessions could go ahead, or not be disrupted by sudden rain downpours.

We also support the sustainability principles embedded in the design of the Pavilion, which I am aware has been developed through collaboration with architecture students and staff at Liverpool John Moores University. As an environmental social enterprise, Grow-Wellbeing CIC is concerned with climate change, increasing environmental awareness, and promoting and implementing sustainable policies in our work. We are therefore pleased to see the sustainable design features being incorporated into the construction of the Pavilion, including green roof, use of timber and rainwater harvesting. These elements will provide the stimulus for further discussion with current and future garden users about the actions that we can all take to reduce our environmental impact and take action on climate change.

There has been an increasing body of research which evidences that connecting with nature spaces is beneficial to people's health and wellbeing; helping to overcome social isolation and mental health

issues. In short, what is often referred to as green social prescribing - an alternative to prescribing medication, offering preventative health and also recovery from illness. The Callister Garden offers the environment to do just that, and the Pavilion will improve and build on what they have achieved over the past few years.

To conclude, Grow-Wellbeing CIC is supportive of the proposal to construct a new Pavilion in the Callister Trust Garden, which will improve the provision, enabling more local residents to access the garden, increasing their connection with nature, increasing their environmental awareness and enhancing their health and wellbeing.

I would be happy to meet or talk further about our involvement with the Callister Trust Garden if required.

This is so important for our members as they suffer greatly from mental health issues, trauma and immense feelings of isolation. For them, discovering such a green and peaceful oasis and a welcoming community in their new town is a benefit beyond words, particularly when you consider how many of these groups are afraid to visit local, public parks. Callister Garden offers a seclusion and safety that our members depend on.

We would welcome the opportunity for this to be a viable venue during the colder months. Many of our members believe cold wind and inclement weather to cause sickness and disease and are actually afraid to be outdoors during this time. An indoor space within the walls of Callister Garden would mean activities and groups could connect at any time of year, and whatever the weather. We would also like to be able to open up the shared projects we do at Callister Garden (Growing Together) to more of our members, and a purpose built facility with modern access would enable this.

We envisage so much potential for increasing our participation at Callister Garden events with the provision of an indoor space, which would be a huge benefit for our members, many of whom live locally, and we do hope to see this happen very soon.

# Reader Community Group in Callister Garden.

The Reading Group supported by The Reader Organisation had been meeting weekly indoors for over 3 years in the Oxton community shop when Covid lockdown stopped meetings in March 2020. Having access to Callister Garden we were delighted to be able to resume meeting outdoors on Tuesday 9<sup>th</sup> June 2020 when some restrictions were lifted. The Trustees were pleased to welcome a Reading Group to their catalogue of uses.

We were forced to switch to Zoom when restrictions were re-instated on 20<sup>th</sup> October 2020 and continued to 22<sup>nd</sup> December. Everyone was disappointed that we could no longer meet outdoors because we were determined to carry on outdoors until the weather made it too difficult. We resumed meeting outdoors in Callister Garden as soon as the weather permitted in the Spring. Numbers have varied from the level we were used to indoors before Covid but at the moment the outdoor group has 7 regular participants. Having said that it is still enjoyable reading if there is only one other person there; the 'group' seems just as worthwhile. Some people are still nervous about being in an indoor group, for others getting back to normal means other commitments but in many ways an outdoor group has its own merits in such a quiet place. If there were an indoor space that we could use in particularly inclement weather it would be wonderful but it is our intention to stay outdoors whenever possible. The advantage of a pavilion, of course, is that it is designed to feel like an outdoor space indoors and there would be the facilities to have a hot drink and to keep warm and dry whatever the weather.

Spider offers over 40 creative, educational and wellbeing activities to improve resilience and self-efficacy, whilst reducing social isolation and improving wider determinates to poor mental and physical health in a non-clinical setting.

For the past three years, Spider Project members have benefited from the space offered at Callister Garden. Member of Spider can freely attend sessions on offer at Callister, additionally we also benefit from having our own Project allotment there. Being in the outdoors naturally can help to improve a creative mind and complements learning, all of which adds to the plethora of support on offer in Spider. Going to other venues and outside spaces further increases confidence and reduces isolation.

Moreover, Spider have been afforded the opportunity to be part of a wildlife project with Callister and other organisations such as Bee Wirral. Part of this project has resulted in Members covertly filming the wildlife in Callister. This has inspired artwork and other classes within Spider.

If the Callister Garden were to have an indoor space this would further open up more group opportunities particular in the winter and in the evening. These are particularly isolating times for Spider members. Spider itself would also have access to run other sessions away from the project such as yoga and mindfulness.
